



Business Improvement District Quality of Life Enhancements

- Clean / Green
 - Pressure washing entire area
 - Keeping public areas clean of debris
 - Maintenance of problem trash areas

 - Institute new tree program
 - Street Furniture program

- ** City admin fees not included




Echo Park BID — "How to"


- Raise Seed money necessary
 - \$40,000 by May 15th
 - OR \$30,000 plus \$10,000 in kind (offices / supplies / work)
- Need Anchor property owners support
- Once we have the support and \$
 - We apply to city of Los Angeles
 - They hire consultant
 - Consultant does study that will help with the overall budget, and map / location of BID
 - Then Vote: we will need 50% of the property owners who voted+ 1
 - Insurance Our Directors and Officers Insurance can be altered to include the BID. Est. Annually at \$12,000 \$15,000.
